

**THRESHOLD INSPECTION:** Our staff performs structural inspections on Threshold Buildings as required by the Florida Building Code. These periodic inspections are conducted in a timely manner, according to the client's needs, to ensure there are no delays in the completion of the project.

**FORENSIC INVESTIGATION:** Our staff helps determine the causes and effects of construction defects or damages that result in breaches to the building envelope and damage to interior components or property. We then assist in repair planning to ensure that damaged or defective components are brought up to the required standards and all breaches are corrected.
